CITIZENS INPUT –

Jane Puckett – asked questions related to the sewer project and whether or not there was a need to add her name to a list. Mayor Tune and Mr. Sharber explained that there was no such list.

Betty Richardson (of Old Hwy 99) – expressed concern over the impact that the sewer project may have on her property and the issue of being charged for the sewer service even if she chooses to refuse the service. Mayor Tune and Chief Stuard explained the process for the project and potential for alternate tank sites at her property.

Betty Richardson (of Main St.) – expressed concern for the limit on the number of linear feet the sewer project could cover onto her property, which is set back 1,100 feet, and also expressed concern for a water leak on her property. Jeff Broughton (MTAS) and Mr. Long (CUD) discussed the hookup requirements according to the ordinance and discussed what might be done by CUD to locate the leak.


